

CAR BOOT & LOCAL MARKET TERMS AND CONDITIONS FOR SELLERS

Seller entry for set-up is from 8am to 9am. The event will run from 9am – 1pm. Please note: Seller entry from 8am. Buyer entry is from 9am (early buyers) and 10am (general admission). Sale closes at 1pm.

SELLING IS NOT PERMITTED BEFORE 9AM

PRE-BOOKING VIA OUR WEBSITE TICKETING SITE IS REQUIRED. Vehicles are parked in strict order and all vehicles are parked side on to provide maximum selling space. IF YOU TURN UP ON THE DAY WITHOUT PRE-BOOKING, YOU WILL PAY AN EXTRA 20% ON THE FEES BELOW.

Entry Fees 2024

Early Bird 10% off below prices until 30/4/24.
Standard Car, Estate, SUV, MPV (and walk-ins) £10
Standard Panel Van, Pick-ups, Combi or Camper Van £15
Large, Luton or LWB Panel Van £20
Horsebox & Lorries from £40
Trailers an additional £5

Payment covers the contents of one vehicle only. No second vehicle unloading (or dropping off) is permitted without full payment on entry. Payment is non refundable and non transferable.

Early buyer entry from 9am is £2 per person. General buyer entry is from 10am and is FREE.

Strict Conditions for Entry

Selling is not permitted before 9am. Please focus on setting up your own stall.

The following items MAY NOT be sold at the Car Boot Sale:

Tobacco · Cigarettes · Drugs · Paracetamol · Fireworks · Crossbows · Air Rifles · Weaponry · Knives · Alcohol · New Toys without a CE safety mark · Giant Lighters · Live Animals · Plants · Flowers · New Garden Products · Pet Foods · Catering · Foods · Drinks · Confectionery · Unsafe or incorrectly labelled electrical goods · Age related items to underage persons · Counterfeit or Copied Goods · Any item not within the sellers legal ownership

All items sold at car boot sales, new and old, are required to comply with the Consumer Rights Act 2015. Information & advice on selling at car boot sales is available from Citizens Advice. Click here for link to Citizens Advice

All items including unsold goods & refuse must be removed from site at the end of sale and taken away with you. It is a criminal offence to publicly discard rubbish and a statutory fine of £150 will apply up to the maximum limit of £2,500.



For disposal of household waste and refuse please make use of your local household recycling centre.

We do not permit selling, touting, trading, advertising or hawking outside of the designated car boot sellers area.

We do not permit leafleting of vehicles or individuals on any part of our farm, property or car park.

We do not permit overnight camping in the car park or car boot areas, or the lighting of fires.

We do not accept antisocial, drunken, rude, improper or aggressive behaviour, damage or theft of property or littering.

Dogs are permitted on site but must be kept on a lead. Please observe the Countryside Code. DO NOT bring dogs on a hot day as there is no shade in the field. NEVER leave a dog in a hot vehicle, even for a short while. Please see RSPCA recommendation. Please be aware that it is an offence to permit your dog to foul on site. Please do not leave or litter the countryside with used dog poo bags.

Hints & Tips for Sellers

Read our Terms & Conditions above before selling items at the car boot sale for any item restrictions. Once you're ready, sort out your goods ready for sale, consider the values and ideally price them up before you arrive. If safe and practical, load up your car the night before and remember to put your table or groundsheet in last.

Watch the weather forecast, and prepare for your day ahead. There is no shade or shelter from rain or sun in the field so a handy umbrella is a useful addition. If there is a chance of rain, a plastic cover would be handy to cover your items too.

Some sellers like to use a gazebo, canopy, awning or umbrella if the forecast is unsettled. We do not make an additional charge to add one above your stall but you will need to consider the space in your vehicle and the time to erect it. Please also ensure gazebos are well secured to the ground, and be prepared to remove if there is a strong wind. Stubbings reserves the right to request the removal of any equipment if deemed to be unsafe, not fit for purpose or if the weather conditions deteriorate.

The car boot sale is an 'old school' cash environment. There are no card facilities at the car boot sale. Do bring PLENTY of change with you. Do not leave cash unsecured. However, Stubbings Café and Nursery will take card payment for goods and entry.

Do make sure that your boot is locked when you arrive and until you are ready to set up.

We recommend that you bring a friend or relative to share the day. You'll appreciate the help to mind your stall when you need the loo or a coffee break, and help watch over your goods if you are engaged with a buyer.



You are very welcome to bring refreshments for your own consumption but please note that you may not sell drinks, foods or sweets at the car boot sale as there are strict regulations controlling the sale of foods. Stubbings will have food and drink for sale.

Please note our access gates do not open before 8am.

For the safety of all buyers, sellers and staff, we ask you do not move your vehicle during the Car Boot Sale. We will announce when the event is finished and will direct you out row by row. If you need to leave for a medical emergency, please do talk to one of our members of staff.
